

**Philadelphia Bar Association  
Board of Governors  
December 21, 2009**

The Chair Gaetan Alfano called the meeting to order at 4:12 pm. He asked that the Secretary's minutes from the November 19, 2009 meeting be approved. Upon motion made and seconded, the minutes were approved.

Treasurer Joseph Prim presented the Treasurer's report for the period ending November 30, 2009. Treasurer Prim reported that revenue projections were exceeded by more than \$92,000 on account of membership dues and fees from LRIS. He also reported that expense projections were exceeded by more than \$86,000. The net impact is that the Association is approximately \$5,800 over-budget.

Executive Director Ken Shear acknowledged the hard work of the Association's staff and, in particular, thanked Andrea Morris for doing a fabulous job in her relentless collection of membership dues. Executive Director Shear also explained that this was a great year for LRIS, whose panel members he characterized as the unsung heroes of the Association. Over \$400,000 in fees were collected from LRIS to date. Executive Director Shear also thanked the Treasurers and Chief Financial Officer Susan Knight. Upon motion made and seconded, the Treasurer's Report was unanimously approved.

Chancellor Sayde Ladov congratulated Mark Fineman, who chairs the Association's bike team for the American Cancer Society ride. The Association's team reached the platinum level for fundraising and received a trophy for its efforts. Chancellor Ladov congratulated all who ride for and contribute towards ACS.

Chancellor Ladov reported that she attended the Section holiday parties and had a great experience at each event.

Chancellor Ladov reported on the success of the December 8 Annual Meeting, recognizing Scott Cooper as the Incoming Chancellor as well as the contributions of award recipients Judge Annette Rizzo, Joseph Sullivan and Andre Dennis.

Chancellor Ladov thanked the Association's staff for their hard work and support, including Brian Sims, Charlie Klitsch, Paul Kazaras, Mary Jane Bonfiglio, Amy Seefeld, Jeff Lyons, Wes Terry, Michael Petitti and Martha Phan. She also welcomed back Mark Tarasiewicz to the staff. Chancellor Ladov then thanked Chair Gaetan Alfano for his wit and intelligence, as well as the Board of Governors for their work. Finally, Chancellor Ladov thanked Executive Director Ken Shear for his friendship and institutional memory.

Executive Director Shear welcomed Mark Tarasiewicz back to the Association staff as the new Associate Executive Director of Communications.
